## EverServe® Springless Model 521S Aluminum Limited Warranty

The distributor of Overhead Door Corporation products identified below ("Seller") warrants to the original purchaser of Aluminum Sectional Model 521S Doors ("Product"), subject to all the terms and conditions hereof, that the Product and all components thereof will be free from defects in materials and workmanship under normal use for the following period(s), measured from the date of installation. Seller's obligation under this warranty is specifically limited to inspecting and replacing components, per the service/replacement schedule shown below.

• SELLER WARRANTS ALL MECHANICAL DOOR SYSTEM COMPONENTS AND THE CONTROL PANEL HARDWARE FOR A PERIOD OF 24 MONTHS OR 300,000 CYCLES\* WHICHEVER OCCURS FIRST (**EXCLUDING THE KNOWN HIGH WEAR COMPONENTS LISTED BELOW**).

- 25K STD Service: Inspect everything, lubricate, and reset limits.
- 50K: Preemptive replacement of cables and STD Service.
- 75K STD Service (See #1)
- 100K: Preemptive replacement of cables and STD Service.
- 125K: STD Service (See #1)
- 150K: Preemptive replacement of cables, cable tension switches, and pusher springs (if applicable), and STD Service.
- 175K: STD Service (See #1)
- 200K: Preemptive replacement of cables and STD Service.
- 225K: STD Service (See #1)
- 250K: Preemptive replacement of cables and STD Service.
- 275K: STD Service (See #1)
- 300K: Preemptive replacement of cables, hinges, rollers. Sections subject to replacement due to fatigue at the hinges.

• SELLER WARRANTS THE OPTIONAL POWDER COAT FINISH ON THE DOOR SECTIONS AGAINST FADING, CRACKING, BLISTERING, FLAKING OR PEELING FOR A PERIOD OF THREE (3) YEARS.

Seller's obligation under this warranty is specifically limited to repairing or replacing, at its option, any part which is determined by Seller to be defective during the applicable warranty period. Seller's repair or replacement labor is included for a period of one year from the date of installation. After one year, any labor charges are excluded and will be the responsibility of the purchaser. This warranty is made to the original purchaser of the Product only, and is not transferable or assignable. This warranty does not apply to any unauthorized alteration or repair of the Product, or to any Product or component which has been damaged or deteriorated due to misuse, neglect, accident, failure to provide necessary maintenance, normal wear and tear, or acts of God or any other cause beyond the reasonable control of Seller. Polycarbonate window inserts require special care and cleaning; this warranty excludes any damage caused by any failure to strictly follow manufacturer's instructions with regard to cleaning. This warranty does not apply to any damage or deterioration caused by exposure to salt water, chemical fumes or other corrosive or aggressive environments, whether naturally occurring or man-made, including, but not limited to, environments with a high degree of humidity, sand, dirt or grease or blowing sand, dirt or other abrasive materials. This warranty specifically excludes any damage resulting from scratching, abrasion or impact by any hard object, and any fading or color change which may not be uniform due to unequal exposure of the door sections to sunlight or other elements. THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL SELLER BE RESPONSIBLE FOR, OR LIABLE TO ANYONE FOR, SPECIAL, INDIRECT, COLLATERAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES, even if Seller has been advised of the possibility of such damages. Such excluded damages include, but are not limited to, loss of goodwill, loss of profits, loss of use, cost of any substitute product, interruption of business, or other similar indirect financial loss. Claims under this warranty must be made promptly after discovery, within the applicable warranty period, and in writing to the authorized distributor or installer whose name and address appear below. The purchaser must allow Seller a reasonable opportunity to inspect any Product claimed to be defective prior to removal or any alteration of its condition. Proof of the purchase and/or installation date, and identification as the original purchaser, may be required.

\* The number of cycles referred to herein shall be measured by an integrated cycle counter contained in or attached to the Product. If the cycle counter is rendered inoperable, Seller shall use other reasonable means to determine the cycle count.
